Seeking a qualified individual to conduct extension and outreach activities related to the management of forests for wildlife in the Central Hardwood region of Indiana. The successful applicant will work towards the completion of an extension/outreach video, publication, podcast, infographic, and/or workshop (depending on the interests of the successful applicant) related to the management of forests for wildlife and the Hardwood Ecosystem Experiment (<https://heeforeststudy.org/>). The successful applicant will be expected to produce or make considerable progress towards the completion of at least one extension deliverable (video, workshop, etc.) by the end of the 8-week internship as well as contribute to a Forest Management for Wildlife Landowners Workshop.
